Tantalizing Turkey Burgers

Below is a really wonderful recipe that starts with ground turkey and turns it into something so flavorful you might find yourself moaning with delight as you feast. This recipe is an extremely flavorful way to incorporate a healthy version of a decadent tasting burger. Submitted by Susan Wright.

1 lb. ground turkey

4 Tbsp. Low Sodium Teriyaki Sauce

4 Tbsp. Low Sodium Soy Sauce

3 Shakes Worcestershire Sauce

1 Bunch Green Onions

4 Jalapeño Peppers

8 Harvest Grain Whole Grain Bread Slices

1/2 cup Fresh Cilantro, Chopped Fine

Lime Juice from 1 Lime

1/2 tsp. Garlic Powder

½ tsp. Cumin

1/4 tsp. Pepper

1/2 tsp. Mrs. Dash Garlic & Herb Seasoning



First remove the seeds from the jalapeños and chop fine. Clean and chop fine the green onions including most of the green part. Saute jalapeño peppers and green onions in 1 tsp. of olive oil until softened. Put all other ingredients into a bowl and add the sautéed peppers and onions to the mixture. Mix well. Form patties and cook in grill pan with a small amount of olive oil until brown and grill marks appear. Turn and cook well on other side. Toast the bread and apply some jalapeño ranch dressing to the bread and then add the burgers. The texture of the bread with the flavorful turkey is a magical combination. I like to serve with fresh cole slaw and sliced tomatoes. Enjoy!
